



The course your son/daughter/ward has chosen to study includes industry standard units that will require regular close contact with their tutors and their peers. This is to allow for effective demonstration of industry standard practices and allow for regular enactment of these standards for training purposes. All demonstrations and practices would be carried out in a group setting and delivery/practice of said standards in line with industry recommendations.

Some of the practices that would be carried out are detailed below.

- Manicure and Pedicure
- Spray tanning
- Facial treatments
- Eye treatments
- Waxing- including lip, chin, underarm, full leg and bikini/ groin area.

Learners are expected to practice these treatments on each other and also clients for their assessments.

Patch tests for certain treatments will be needed to be carried out here at college including eyelash/brow tinting and glue. Care instructions will be given by the tutor in class during the patch tests.

Some treatments may need the removal of certain clothing for the treatments to be carried out. For example, waxing, facials and spray tanning. Many treatments will involve physically touching your peers or being touched by your peers or tutor to enable effective demonstrations or practice on technique to take place.

## **Expectations:**

- Kit, correct shoes and uniform is needed and brought into college everyday that the learners are timetabled to be in.
- It is essential that on the learners first day of college all nails should be natural with no acrylic, gel or nail polish.
- No eyelash extensions are allowed.
- No jewellery or watches should be worn except one pair of stud earrings.
- During practical sessions hair must be worn in a bun.
- Make up should be applied naturally and be expected to be removed during certain treatments.
